a. President's Report

Graduate scholarship act (SB 180) was introduced to legislature but died in committee.

SB48 for grants funding was passed but has not yet been signed by governor

Ouestions:

Pena-Parr: What is current funding level in general fund and how would this be impacted by Bill 2021-004

Pena-Parr: What is president's office balance forward fund.

Saavedra: Can obtain it. Condensing accounts so they don't just contain single items.

Karmakar: Constraints for Bill 2021-004 were not mentioned until after veto

Saavedra: Feel that there was not enough discussion

Block: Question on \$2600 figure. If RDSA doesn't use money then wouldn't they need less money next time.

Saavedra: There is not a safeguard to prevent stacking of new PB fund requests.

Linquist: PB funds are allocated fully based upon number of people in the RDSAs

Saavedra: Also see my survey that was sent out

Olofinsao: I will yield because my question was about survey Henkel: Thank you to Pena-Parr for question about balance in general fund. Can look at finance minutes. Thanks to President for looking at this carefully. We appreciate that he is open to override of veto.

b. LSC bills

i. Reconsideration of Bill FA 2021-004

Discussion:

Block: Pros of Bill outweigh cons. I'm in favor of empowering our RDSAs. Keep money closer to students

Pena-Parr: \$2000 will not make big impact to GPSA. This money will further student engagement. You're closer to your department than the GPSA. Will not make a big hit to budget.

Don't see benefit to veto and recommend we override

Henkel: I agree that we should override. Groups can keep money close to them and get it more easily with less red tape and less jumping through hoops. Can fund conferences and departmental grants, etc. Easier access. Groups will be able to respond more quickly. If executive controls this then it could

take too long and president may not know the details about budget. We can also reconsider funding to groups at later date.

Olofinsao: Consider what benefit this would have to each

RDSA. Others have pointed out the benefits to student groups.

Hamid: Reiterate other sentiments. One point is that it is more quickly accessible. When money is needed for emergencies, it can benefit students in a quicker way.

Pena-Parr: This funding will go a long way for an RDSA but will not make big impact on GPSA
