62		official sponsorships based upon the grounds of moral disagreement,
63		perceived discrimination, or abuse of their position as an affiliated or official
64		sponsor of GPSA. The President is not obligated to honor the request on
65		these grounds alone but is obligated to publicly recognize this request and
66		state their reasons for either honoring or not honoring it. This recognition
67		and explanation need to take place within 14 calendar days of receipt.

69	5.	Any person, group of persons or organization that has had an affiliation or
70		official sponsorship terminated before the end of an academic year and
71		wishes to enter a new sponsorship, either within the same academic year or
72		another, must address the reasons outlined in the written explanation of the
73		termination that was presented to Council in their new request for affiliation
74		or official sponsorship. In their address they should state why these reasons
75		will not be an issue under a new affiliation or official sponsorship agreement.
