- b. Adoption of Agenda
 - i. A motion to adopt the agenda is made and seconded, and the motion is adopted by the council.
 - ii. The council chair reads out the indigenous peoples' land and territory acknowledgement. The President reads out the statement acknowledging the labor and sacrifices of black Americans.

III. Officer Reports:

- a. **President Michel Rivera Ramirez:** Michele welcomes everyone to the first council meeting of the year and highlights the efforts made over the summer to standardize council operations. He also mentions the awarding of over \$50,000 in summer grants and the upcoming fall grant cycle starting in September.
- b. **Council Chair Ashish Ravi Joshi:** Michelle discusses the outreach efforts made in August to previous council members and board of directors to update the RDSA

application process. He notes the increased attendance at meetings and the distribution of printed folders containing parliamentary procedure cheat sheets and other important documents. Plans for an orientation on parliamentary procedures and other topics are mentioned, with a focus on ensuring all council seats are filled by the end of the year. The importance of addressing issues faced by graduate students, such as parking, mental health, and safety, is emphasized, with suggestions for forming subcommittees to address these issues.

IV. Committee Reports

a. **Grants Director Joseph Conteh:** Joseph Conteh provides a report on the summer grant and scholarship cycle, highlighting the awarding of \$52,600 in grants and scholarships. Specific grants and scholarships mentioned include the Student Research Grant, Professional Development Grant, and Guidance Scholarship Fund. Concerns about the HSC Rural Rotation grant and the need for further funding are discussed, with plans to work towards securing this funding. The importance of attending workshops as a requirement for grant eligibility is emphasized, with strong recommendations from the accountant.

 - A motion to open the standing rules for discussion is made and seconded, and the standing rules are opened for debate.
 - The main change discussed is the move towards in-person meetings to facilitate better communication and engagement among council members.
 - The importance of having certified alternates and proxy privileges is reiterated to ensure continuity and representation.
 - All members unanimously agree on having in-person meetings.
 - Members also discuss potential upgrading of facilities to improve hybrid meeting infrastructure if and when needed
 - The meeting concludes with a focus on moving forward with the approved standing rules and addressing the needs of the various departments and their representatives.
 - Members vote unanimously in favor of approving the standing rules.
