3. Add a specific **funding allocation for general body meetings** under Food, which was omitted earlier (previously only large and small events were included).
4. Update *Article VIII, Section 10 (a) (Per Diem)* to include the term “**Lodging and Meals**” and establish a **maximum allocation of \$2,500 per conference per GPSA-chartered student association**, based on discussion with Angela De Avila (SGAO).
5. Update *Article VIII, Section 10 (c) (Airfare)* to establish a **maximum allocation of \$5,000 per conference per GPSA-chartered student association**, also based on discussion with Angela De Avila (SGAO).
6. *Article V, Section 3 (Suspension of Rules)*: clarified the conditions under which Standing Rules may be suspended.
7. *Article VIII, Section 8 (Food and Refreshments)*: revised language regarding alternative sources of funding — previously limited to ASUNM, now broadened for consistency.
8. *Article VIII, Section 8 (Honorarium)*: clarified that **travel expenses for honorarium recipients cannot be funded**, correcting the earlier version which allowed limited speaker travel support.
